Membership Additional Notes

- We ask that ALL MEMBERS check in the golf shop prior to their tee time or when utilizing the range
 - We will require a ticket be presented to a member of our outside services staff in order to receive range balls for ALL MEMBERS and GUESTS
- Operation of a golf cart is at the risk of the operator. Cost of repair to a golf cart which is damaged by a member or any family member will be charged to the member or, in the case of damage by a guest, to the sponsoring member. Members using a golf cart will be held fully responsible for any and all damages, including damages to the golf cart, that are caused by the misuse of the golf cart by the member, any family member or their guests, and the member shall reimburse the Club for any and all damages sustained to the cart by reason of misuse. The member using a golf cart accepts and assumes all responsibility for liability connected with operation of the golf cart.
- Tee Times
 - Please make sure to reserve a tee time through our online system or by calling the golf shop at your earliest convenience so that we can be prepared for your arrival as well as to make sure we have availability
 - Please notify the golf shop at least 2 hours prior to your tee time reservation should you need to cancel or make changes to the booking
 - In order to hold tee time reservations for more than four players we will need all names at least 24 hours prior too. Should we not receive at this time the tee time will be released!
- GIFT CARDS WILL NOW ONLY BE ALLOWED FOR MERCHANDISE, LESSONS AND ROUNDS OF GOLF ONLY AND CANNOT BE APPLIED TO YOUR ACCOUNT
